Regular Giving



If you have a regular salary or pension then it can help the church and you to make a regular donation by standing order. You can choose the timing of the payment, it is usually best to choose a date just after the date on which you receive your salary or pension. If you are a UK taxpayer, please sign a Gift Aid Declaration form.

UK Taxpayers

Gift Aid

You sign a Gift Aid Declaration form for each charity you support. You are signing to say that you pay enough tax to cover the tax that the charities will recover in the tax year in question. After that, the charity does all the work actually reclaiming the tax. The gift aid form can be found on the back page. Once completed, please place it in the collection box.

Give As You Earn

A scheme operated by some employers. The result is similar to using the Gift Aid scheme but the charity doesn't have to reclaim the tax because the record keeping is done by the employer. The employer deducts your donation from your gross pay, then passes on the amount donated to the Payroll Giving Agency who in turn forwards the money to the charity.

Envelope Scheme

Sign a Gift Aid Declaration form and ask for envelopes marked with an assigned donor reference number. Place your donations into the envelope and put these in the collection box by the entrance to the worship area. This provides a degree of anonymity for cash donations, whilst enabling us to identify the donation as one for which the tax can be reclaimed.

Funds

Donations, unless otherwise specified, will be credited to the general fund, which is used for most church running expenses.
